

They may just drop a mail at cmss.vendor@gmail.com for any delayed payments [beyond tender terms i.e. 60/75 days (for non-sterile/sterile products) of complete invoice submission] & same shall be addressed. Also, the vendors can themselves see various stages where invoice has reached at supplier interface of E- Aushadhi.

It is to assure our esteemed bidders/suppliers that they need not pay heed to any such pressure for hiring some particular person (Ex or working official of CMSS or entity formed by Ex-employees) for facilitating-Tender processing/Quality testing process or Invoice payments.
