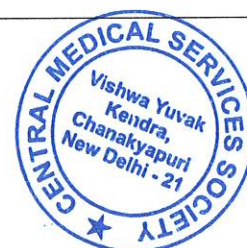

After due processing, if it is discovered that the quantity to be ordered is far more than what L-1 alone is capable of supplying/ L1 has offered to supply, then purchaser reserves its rights to distribute the qty. being finally ordered , among the other bidders by counter offering the L-1 rates to willing L-2 or higher bidders, in transparent manner to avail full assessed capacities of lower priced bidders first, before inviting higher- priced bidders. The decision of Procuring Entity shall be final.</p>
