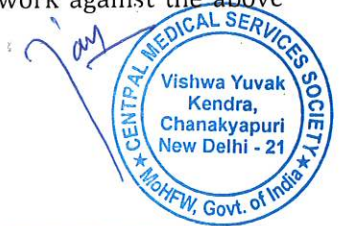

**Subject: - Debarring of M/s A-One Services for participation in Transportation Tender of CMSS Guwahati, Mumbai & Patna warehouse locations for a period of 01 year from the date of issue of this letter, i.e. from 02/01/2026 to 01/01/2027.**

Reference: - Show Cause Notice (Letter No. - LSC/TEND/TRNS/4/2025-LSC-CMSS/838 dated 11.12.2025) issued by CMSS to M/s A-One Services.

Sir/Madam,

1. As cited subject, CMSS issued a Show Cause Notice to M/s A-One Services vide letter no. LSC/TEND/TRNS/4/2025-LSC-CMSS/838 dated 11.12.2025 requesting submission of a detailed explanation by 18.12.2025. This said notice concern with the terms and conditions of the contract regarding non submission of performance security to CMSS and not signing the contract agreement with CMSS for transportation services at Guwahati, Mumbai and Patna warehouse locations against CMSS contracts: -
  - i. To initiate proceedings to debar/ blacklisting of M/s A-One Services of one year from Guwahati, Mumbai and Patna warehouse locations for breach the contract in accordance with the above-mentioned terms and conditions of the contract.
  - ii. To cancel the LOA no. LOA no. LSC/TEND/TRNS/4/2025-LSC-CMSS/641 for Guwahati WH, LSC/TEND/TRNS/4/2025-LSC-CMSS/644 for Mumbai WH & LSC/TEND/TRNS/4/2025-LSC-CMSS/645 for Patna WH against Tender no. LSC/TEND/TRNS/4/2025-LSC-CMSS(GEM Bid No.: - GEM/2025/B/6212063) for Guwahati, Mumbai and Patna warehouse locations.
2. However, your firm failed to submit the reply to the Show Cause Notice within the due date. Further, an online meeting was organized on 31.12.2025, during which your representative, Mr. Hariom Sharma, Confirmed that your organization is not willing to undertake the work against the above mentioned LOAs.

3. According to clause no. 04 of LOA, "In case you fail to submit the performance security within the stipulated period, the EMD submitted by you will be forfeited and punitive action shall be taken against the transporter including blacklisting."
4. Further, clause on 7.3.2 of tender document stipulates that, "In case successful bidder fails to submit the NEFT/RTGS/Demand Draft (DD) as Performance Security, the EMD submitted by the respective bidder will be forfeited and punitive action shall be taken against the transporter including blacklisting."
5. In view of aforesaid provision of tender document, the following decision have been taken with the approval of Competent Authority with the immediate effect:-
  - i. To debar/ blacklisting of M/s A-One Services for a period of 01 year from the date of issue of this letter, i.e. from 02/01/2026 to 01/01/2027 from participation in transport activities at Guwahati, Mumbai and Patna warehouse locations, for breach of contract in accordance with the applicable terms and conditions.
  - ii. Cancellation of the LOA no. LSC/TEND/TRNS/4/2025-LSC-CMSS/641 for Guwahati WH, LSC/TEND/TRNS/4/2025-LSC-CMSS/644 for Mumbai WH & LSC/TEND/TRNS/4/2025-LSC-CMSS/645 for Patna WH against Tender no. LSC/TEND/TRNS/4/2025-LSC-CMSS (GEM Bid No.: - GEM/2025/B/6212063) for Guwahati, Mumbai and Patna warehouse locations.
