1. Introduction

CMSS invites bids from Chartered Accountant (CA) firms that are empanelled with the Comptroller and Auditor General (CAG) of India. These firms will be responsible for verification of physical medicine stocks at 18 CMSS warehouses across India **for the period of two (02) years and further extendable by another one (01) year (on mutually agreed terms and conditions).**

1.1. About CMSS

The Central Medical Services Society (CMSS) is a central procurement agency under the Ministry of Health and Family Welfare. It is responsible for purchasing and distributing medicines and medical equipment to different government health programmes of India.

CMSS warehouses store large quantities of medicines and supplies, and it is essential to regularly verify these stocks physically to ensure transparency and accountability. This tender is to hire qualified CAG empanelled auditors who will perform this task.

1.2. Purpose of the Tender

The purpose of this tender is to hire a qualified CAG Empanelled CA Firms that can physically verify the stock records and verify that the medicines stored in the warehouses match the records.

- a) CMSS reserves the right to accept or reject any or all the Tenders without assigning any reasons thereof. CMSS also reserves the right to call for any other details and information from any of the tenderers.
- b) CMSS does not bind itself to accept the lowest or any tender and may cancel / withdraw the tender without assigning any reason, and no claim whatsoever, for any reason arising out of such action, will be entertained by CMSS.
- c) Late/delayed bids shall not be accepted under any circumstances after the due date and time of submission of the tender.
- d) **Cost of Bidding:**
 - (i.) The bidder is responsible for all costs related to preparing and submitting their bid through the **GeM portal**. CMSS will not be liable for any of these expenses under any circumstances.
 - (ii.) CMSS will not be accountable for any expenses or losses incurred by any bidder in connection with the submission of their tender.

2. Scope of Work

2.1. Instruction and information

- 2.1.3. Central Medical Services Society reserves the right to reject any or all tender process without assigning any reason thereof at any stage
- 2.1.4. Late/delayed bids will not be accepted under any circumstances after the due date and time of submission of tender.
- 2.1.5. Conditional Bids will be rejected.
- 2.1.6. Corrigendum (if any) will be uploaded on GeM Portal and all prospective bidders are requested to see the GeM website regularly for any update.
- 2.1.7. Not more than one tender shall be submitted by one bidder or bidders having business relationships.
- 2.1.8. CMSS will not send any corrigendum/ pre-bid meeting details to any bidders through emails/any medium, the same will be uploaded on GeM Portal only.

2.1.9. The stock of CMSS is being maintained through an application known as e-Aushadhi that provide end to end solution for stock monitoring and controlling including various reports, alerts etc. The total average value of stocks of all 18 warehouses of CMSS across India as on 08th December 2025 is of approx. Rs.601 Crore.

2.2. The CAG Empanelled CA Firm's job will include:

2.2.1. Checking Stock Records: The auditors will check the actual (physical) warehouse stocks by comparing them with the e-Aushadhi system.

2.2.2. Physical Stock Count: Auditors will conduct a physical count/verification of all (100%) medicines stored (stock includes active and quarantine medicines) at the warehouse and compare it with the records.

2.2.3. Reporting Discrepancies: Any difference between the physical stock and the records should be noted. Auditors may mention the reason of discrepancy occurred.

2.2.4. Detailed Audit Reports: A full report in originals must be submitted for each warehouse at CMSS HQ New Delhi as per **ANNEXURE-II**.

2.3. Duration of the Work: The stock verification at each warehouse may take one or two days, depending on the stock volume. Ideally, the verification should be completed in a single day to minimize disruption to the receipt and distribution of medicines. Alternatively, verification may be conducted on a Saturday or Sunday.

2.4. Completion Date: The complete stock verification process including submission of **full report for each warehouse must be completed by 15th March of the respective Financial Year**. The rate contract will be valid and fixed for the period of two (02) years and further extendable by another one (01) year (on mutually agreed terms and conditions).

2.5. Bidding procedure: The bidding process will be conducted through the **GeM** portal only.

2.6. Selection Process: CAG Empanelled CA Firms may choose to undertake stock verification for one or more warehouses, or all 18, depending on their capacity and accessibility. Evaluation of financial ranking of bids shall be done separately for each warehouse and Bidder has the option to submit their quotation/rates for any one or all warehouse locations.

2.7. Site visit: If necessary, auditor's firm may visit the nearest warehouse before bidding with the prior approval from the CMSS HQ New Delhi.

2.8. Rate Validity: Rates in the prescribed format of Annexure-V to be quoted for yearly auditing basis only. The selected (L1) bidder's quoted rates shall remain valid for the entire contract period of two years, under the same terms and conditions of the tender document, and may be further extended for an additional period of one year.

2.9. Final documentation book/report: The completed and authenticated final report in the prescribed format along with Unique Document Identification Number (UDIN) shall be required to be submitted to the **General Manager (LSC), Central Medical Services Society, 2nd Floor, Vishwa Yuvak Kendra, Pt. Uma Shankar Dikshit Marg, Teen Murti Road, Chanakyapuri, New Delhi – 110021**

3. Eligibility Criteria

3.1. The bidding firm must fulfill the below eligibility criteria: -

- i. The bidding firm must be empanelled with the Comptroller and Auditor General (CAG) of India on the date of tender opening. Bidders are required to submit a valid CAG empanelment certificate as proof.
- ii. The firm must have at least 05 years of experience in conducting stock or inventory audits, in the PSUs, and government institutions (central or state). Documentary proof of work order/purchase order/satisfactory report/relevant experience certificate/ proof of payment with invoice must be submitted.
- iii. Minimum Average Annual Turnover of the bidder for the last 3 years should be INR 30 Lakh (s). Copy of certified CA certificate for the last three (03) financial year's turnover with UDIN must be submitted.
- iv. The firm must have a qualified team of atleast 02 full time auditors, in which atleast 01 certified Chartered Accountants (CAs) with experience in handling similar or relevant projects must be there. A list of key personnel, along with their qualifications and experience, must be submitted.
- v. The firm must have a valid GST registration number and Permanent Account Number (PAN). Copies of these certificates should be provided as part of the tender submission
- vi. The bidding firm should not have been blacklisted by any government body or public sector company. A self-declaration as per **ANNEXURE-III** must be submitted along with the tender documents.

3.2. The bidder must submit the following documents for fulfilling the eligibility criteria: -

- i. Proof of valid CAG empanelment certificate.
- ii. Documentary Proof of work order/purchase order/satisfactory report/relevant experience certificate/ proof of payment with invoice for past 05 years must be submitted.
- iii. Copy of certified CA certificate for the last three (03) financial year's turnover with UDIN must be submitted for the minimum Average Annual Turnover of INR 30 Lakhs for the last 03 years.
- iv. Documentary proof of number of employees employed with their professional CV.
- v. Copy of GST registration certificate.
- vi. Copy of PAN card.
- vii. Copy of Company's registration certificate.
- viii. Declaration of non-blacklisted as per **ANNEXURE-III**.
- ix. EMD or Bid Security Declaration as per **Annexure – IV**
- x. Tender Submission Letter (Covering Letter) as per **Annexure – VI**
- xi. The bidder shall submit a duly signed copy of the complete tender document, including all amendments (if any), as a mandatory part of the bid.

4. EARNEST MONEY/PERFORMANCE SECURITY

- 4.1.** Each Bidder should deposit **Rs.10,000/-** (Rupees Ten Thousand only) as Earnest money Deposit (EMD) in the form of **NEFT/RTGS/Demand Draft (DD) drawn in favor of Central Medical Services Society**, Payable at New Delhi.

4.1.1. Bidder can bid for multiple warehouses with the single EMD of Rs. 10,000/-

4.1.2. Original EMD in the form of DD/RTGS/NEFT is to be must submitted at CMSS, New Delhi on or before the last date of submission of bid.

4.1.3. The EMD of Rs.10,000/- (Rupees Ten Thousand only) furnished by all unsuccessful bidders will be returned within 45 days after the finalization of the successful bidder.

4.1.4. For the successful bidder, the EMD of Rs.10,000/- (Rupees Ten Thousand only) submitted will be returned as early as possible after submission of performance security amount as mentioned in para 4.3.

4.1.5. The bidder's bid without the submission of above Earnest Money Deposit (EMD), will be summarily rejected.

4.1.6. The CMSS will not pay any interest on bid security amount.

4.2. EXEMPTION FROM PAYMENT OF EARNEST MONEY DEPOSIT TO MSME (MICRO & SMALL ENTERPRISES)

Vide Gazette no. CG-DL-E-26062020- 220191 dtd. 26.06.2020, Ministry of MSME have revised criteria for classifying the enterprises as Micro, small and Medium enterprises with effect from 1st July 2020 therefore following firms will be exempted from submission of EMD.

- a) Micro and Small Enterprises as per classification given in MSME Notification dtd. 26.06.2020 registered under "Udyam Registration" w.e.f 01.07.2020 will be granted exemption from payment of Earnest Money Deposit. Udyam Registration Certificate has to be produced in support of above.
- b) Vide notification no. O.M No. 2/1(5)/2019 - P&G/Policy (pt.IV) dtd. 06.08.2020, Clarification on existing Entrepreneurs Memorandum (EM) Part-III Udyog Aadhaar Memorandum (UAM) I New Udyam Registration-regarding will also be applied.
- c) As applicable, bidder must submit the **"Bid Security Declaration Certificate"** as per **Annexure-IV** in the bid document. **Original Bid Security Declaration Certificate needs to be mandatorily sent to CMSS HQ New Delhi (with sign and stamp) within 07 day of last date of submission of bid.**
- d) The bidder's bid without the copy of above "Bid Security Declaration" (as applicable) in the technical bid will be summarily rejected.

4.3. SUBMISSION OF PERFORMANCE SECURITY

4.3.1. Successful Bidder should submit Performance Security of 5% of the contracted value in the form of NEFT/RTGS/Demand Draft (DD) drawn in favor of Central Medical Services Society, Payable at New Delhi, within the 14 days from the date of intimation for award of contract/Purchase Order/Letter of Award of Contract.

4.3.2. For the successful bidder, who submits the "Bid Security Declaration Certificate", the bidder should mandatorily need to submit the performance security of 5% of the contracted value as mentioned in para 4.3.1.

4.3.3. The performance security will be refunded within 60 days after successful completion of contract and submission of physical audit report of warehouse(s) in originals to the CMSS HQ New Delhi.

4.3.4. The performance security will be forfeited in case of non-compliance to the timelines and deliverables by the bidder as per tender document.

4.3.5. The CMSS will not pay any interest on performance security amount.

5. FINANCIAL BID AND EVALUATION CRITERIA

- 5.1.** Bidders must quote an all-inclusive fee for physically verifying the medicine stocks at each warehouse location (**on annual/yearly basis only**). The fee should cover travel, accommodation, and all other incidental expenses. No other reimbursement of expenses apart from the audited fees will be applicable.
- 5.2.** Evaluation of financial ranking of bids shall be done separately for each warehouse.
- 5.3.** Financial Evaluation will be based on financial quote submitted by technically qualified bidder as per **ANNEXURE-V**.
- 5.4.** The bid shall be evaluated on Least Cost Selection (LCS) basis. The bidder qualifying in the technical stage and quoting the lowest price for each warehouse will be considered as L1 and eligible for further action.
- 5.5.** **Bidders are strictly advised to refrain from uploading or disclosing the Financial Bid/Financial Details/Rates/etc. within the Technical Bid documents and must submit the Financial Bid separately only in the designated Financial/BOQ section of the GeM portal, failing which the bid will be summarily rejected.**
- 5.6.** **These annual rates submitted by the successful L1 bidder will be final & binding for complete contract period. The L1 rates will remain unchanged for the period of 02 years and further extendable period of One (01) year. No change in price will be entertained during complete contract period including extension.**

6. Timeline & Deliverables

- 6.1.** The stock verification at each warehouse may take one or two days, depending on the stock volume. Ideally, the verification should be completed in a single day to minimize disruption to the receipt and distribution of medicines. Alternatively, verification may be conducted on a Saturday or Sunday.
- 6.2.** The physical verification of stocks for each warehouse should be completed within 30 days from the date of receiving the work order. For each location, the physical verification audit report must be submitted in originals to CMSS HQ New Delhi within 20 days of completing the audit.

7. Payment Terms

Payments of 100% amount will be released to the successful bidder on yearly basis, only after the successful submission of the physical verification audit reports of warehouse(s) to the CMSS HQ, New Delhi in original, to the satisfaction of CMSS.

8. General Terms & Conditions

8.1. Termination Clause

- a.** CMSS reserves the right to terminate the contract if the auditor fails to meet the agreed standards or deadlines.

8.2. Force Majeure

- a. If circumstances beyond the control of the parties (such as natural disasters, strikes, or government regulations) prevent the completion of the audit, the timelines may be adjusted accordingly on mutual consent.

8.3. Confidentiality

- a. The auditing firm must ensure that all information related to the stock and operations of the warehouse remains confidential and is not disclosed to unauthorized parties.

8.4. Dispute Settlement & Legal Jurisdiction

- a. If any dispute arise out of the contract with regard to the interpretation, meaning and breach of the terms of the contract, the matter shall be referred by the Parties to the DG & CEO, CENTRAL MEDICAL SERVICES SOCIETY, New Delhi, who will appoint his senior most deputy or the Head of the Department as the Sole Arbitrator of the dispute who will not be related to this contract and dispute should dissolve in accordance with the Provision of the Arbitration Act 1996 and whose decision shall be final. Maybe all legal proceedings, if necessary, arise to institute by any of the parties (Society or Contractor) ought to have to be lodged in courts situated at New Delhi not elsewhere.
